



Dear Parent/Guardian,

We are pleased to be able to offer your son/daughter this opportunity to be a part of the 2026 **Cayman Finance LEAD Programme**. The programme aims to create a pathway for your child into the financial services industry, providing support, insight, and development opportunities along the way.

Your child will be required to fulfil the following requirements to successfully complete the programme:

- Workshops - weekly at specified school/other location (1 hour each for 8 weeks)
- Mentor sessions - 10 total
  - Weekly one-on-one sessions with paired mentor (1 hour each for 8 weeks in May/June)
  - 2 sessions in July or August during work placement
- Work placement - 4-week work placement at a participating organisation (to take place in either July or August)

If your son/daughter has any conflicts with the above scheduling, it will be their responsibility to communicate directly with Cayman Finance and their mentor as this programme is shaped to help them learn accountability, communication, and confidence as they get ready for the workplace.

### Eligibility

The programme is open to all Caymanian students either in Year 12 of the Cayman Islands Government dual-enrolment programme, finishing Year 12 within a Private School (British School System) or finishing Grade 11 within a Private School (American School System). To be eligible for the programme, students will need to:

- Provide a letter from Immigration confirming their Caymanian status. If you are unable to provide the aforementioned document, please communicate this with Cayman Finance so that we may explore further options.
- Provide a letter from their health insurance provider confirming current enrolment
- Have achieved at least a GPA of 2.5 (American School System) or be predicted to receive at least three (3) C or above passes in their academic year. (Your school has confirmed that you fulfil these criteria.)
